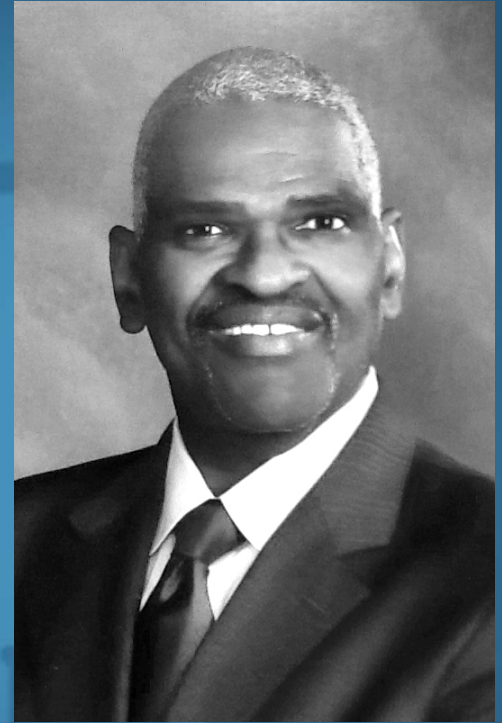

Lucius Durham Battle

- ❖ Served as Naval Officer during World War II in the Pacific
- ❖ Reorganized the State Department as top assistant to Secretaries of State Dean Acheson and Dean Rusk
- ❖ Served as Ambassador to Egypt (1964 – 1967) and twice as Assistant Secretary of State
- ❖ Founding Chairman of the Foreign Policy Institute at the Johns Hopkins School of Advanced International Studies (1980) and Chairman of the National Council on U.S.-Arab Relations (1995-2008)

Rebecca Bowles Hawkins

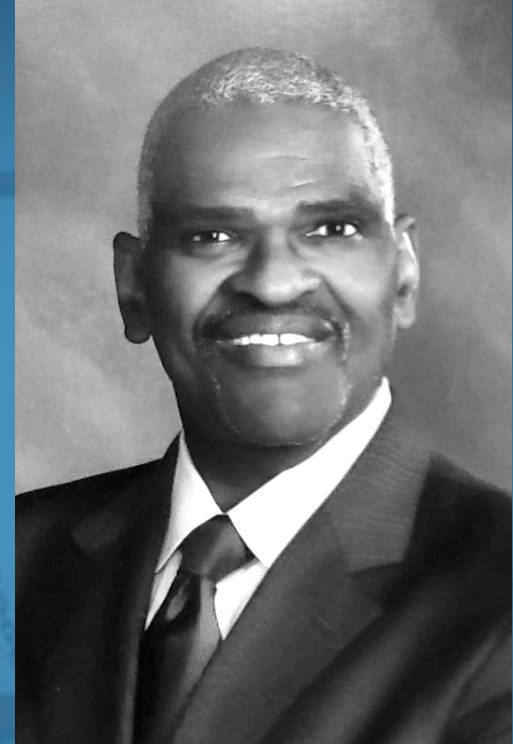
- ❖ Became first female Assistant Attorney General in Florida in 1948 and headed Opinions Division (1969-1976)
- ❖ Full-time Research Assistant for Florida Supreme Court Justice B.K. Roberts
- ❖ Served as President of Florida Association of Women Lawyers (1954-1955) and National Association of Women Lawyers (1960-1961)
- ❖ Named 1997 UF Alumnae of Outstanding Achievement

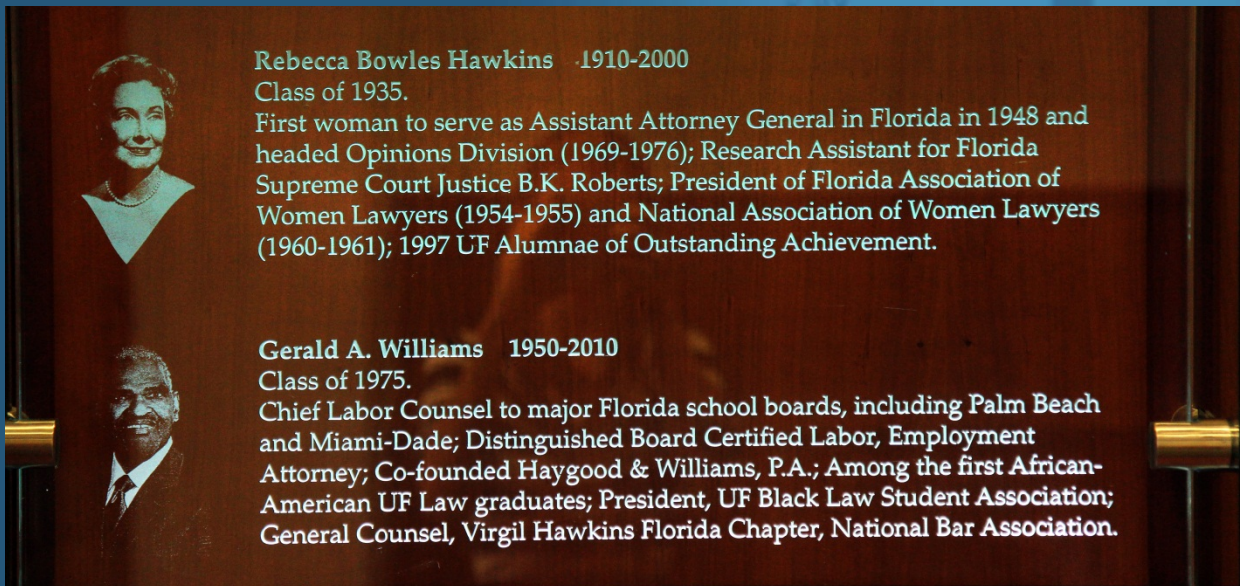
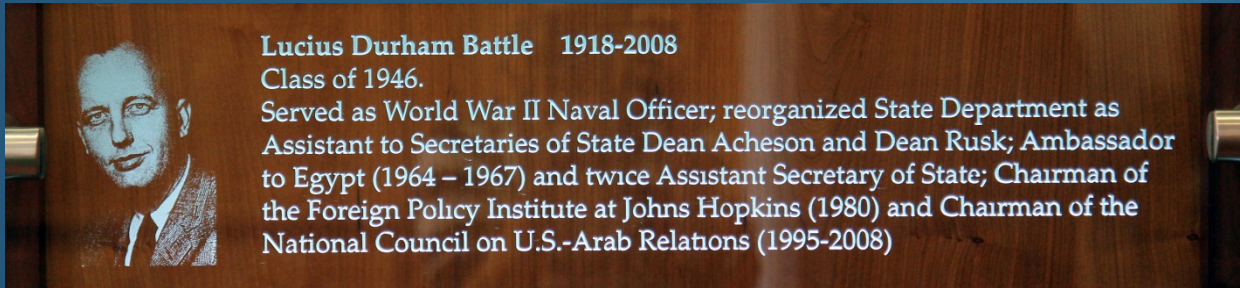
- ❖ Served as president of the UF Law Black Law Student Association
