5. Application materials are due to the Levin College of Law, Office of Student Affairs, PO Box 117621, Gainesville, FL 32611-7621 by the appropriate deadline.
 - *The deadline for the South Africa program is **October 30, 2009**.
 - *The deadline for the Costa Rica and France programs is **March 15, 2010**.

*Incomplete applications will not be evaluated.
