Fuentes v. Shevin, 407 U.S. 67 (1972) (Florida pre-judgment replevin statutes declared unconstitutional)

Livingston v. Garmire, 308 F. Supp. 472 (S.D. Fla. 1970), *aff'd*, 437 F.2d 1050 (5th Cir. 1971), *vacated and remanded*, 442 F.2d 1322 (5th Cir. 1971) (constitutionality of the City of Miami disorderly conduct ordinance).
