1. COURSE OBJECTIVES AND GOALS:

The course will study the real estate transaction, the contract for the purchase and sale of real property and disclosure requirements, and the various formats for ownership of real property. The course will also provide an introduction into mortgaging real property. The course study will include the state and federal statutes and the common law that govern the real estate transaction, the contract, the mortgage, and the forms of real property ownership.

2. REQUIRED TEXTBOOK AND COURSE MATERIALS:

Students should read the assigned materials before each class and be prepared to discuss the assigned materials during class. Students should also read the supplemental materials distributed through the TWEN page for this class. Reading assignments may be changed or added as the semester progresses.

3. METHOD OF EVALUATING STUDENTS AND DETERMINING GRADES:

The format and length of the Final Exam has not been finalized, but you can anticipate that the Final Exam will consist of multiple choice questions, questions requiring short essay answers, and questions requiring a long essay answer. The Final Exam will not be rescheduled unless rescheduled through the law school.

CLASSROOM PARTICIPATION: Each student will be assigned a specific week to participate in class, which will be required classroom participation. Voluntary student participation is encouraged. Classroom participation can increase your final grade by up to one (1) letter grade.

- 2. Describe the different types of deeds and conveyances, including the processes for delivery and escrow.
- 3. Demonstrate an understanding of the different types of land descriptions, including water and land boundaries, the history of the various types of land descriptions, and how to identify the land described by the description.
- 4. Explain the primary warranties, covenants, and assurances of title.
- 5. Demonstrate a working knowledge of mortgage substitutes and general real estate finance.
- 6. Explain the right of redemption and the process and effect of foreclosure.
- 7. Describe and explain the importance of professional responsibility in the realm of real estate transactions.
