Summer Program in American Law for Brazilian Judges, Prosecutors and Attorneys

In July 2018, UF Law's Center for Governmental Responsibility hosted the 19th Annual Summer Program in American Law for Brazilian Judges, Prosecutors and Attorneys. This year's group included federal judges, state prosecutors, legal academics, practicing attorneys, and graduate law students. Participants attended lectures on comparative law and received detailed information on various aspects of judicial and governmental resource administration.

The Honorable Rosemary Barkett, JD '70 joins us for a second year. Former Chief Justice of the Florida Supreme Court and 11th Circuit US Court of Appeals Judge, Barkett currently serves as an arbitrator of the Iran-United States Tribunal situated in The Haque, Netherlands.

Latin American Corporate Law Conference 2018

To be held in November 2018 in Miami, this inaugural event will bring together internationally recognized practitioners from both in-house counsel offices and from law firms to tackle cutting-edge issues in Latin American corporate work. Topics will include mergers and acquisitions, the rise of anti-corruption risk across Latin America, multi-Latinas and family-owned firms, and more.

Kyrgyzstan Judges

UF Law has a continuing partnership with judges from Kyrgyzstan. In 2017, eight Kyrgyzstani judges addressed the UF Law community about gender based violence in the region. In 2018 the judges returned to discuss international family law issues and policies.

Students obtain hands-on experience focusing on transactional legal work and drafting policies with local, national, and international significance. Past clients include the government of Costa Rica.

Annual International Tax Symposium

The 14th Annual International Tax Symposium brings global tax experts to Gainesville to analyze pressing issues.
