# **GRE FAQ**

## Am I required to submit a CAS report if I only take the GRE?

Yes, a CAS report is required for all applicants whether they apply with the LSAT or GRE.

#### Which version of the GRE should I take?

Applicants should take the General GRE test. GRE Subject tests will not be accepted.

#### Can I submit only my highest GRE score?

No, all reportable test scores for the last five years must be submitted with the application.

### How do I report my GRE score?

If an applicant chooses to apply to UF Law with GRE scores, they will instruct ETS to forward all GRE test scores received within the previous five years. They will login to their ETS account and select University of Florida Levin College of Law as a recipient of their scores. UF Law's school code is 3945.

#### How will UF Law evaluate GRE scores?

UF Law compares the percentile scores from each section of the GRE with the percentiles scores of applicants who take the LSAT exam. Comparable percentiles are competitive. For example, the current LSAT median is a 169, which is roughly the 95<sup>th</sup> percentile of all students who take the LSAT. Competitive GRE scores should be around the same 95<sup>th</sup> percentile.

#### How will UF Law evaluate multiple GRE scores?

Generally, UF Law will give the most weight to the highest reported GRE score for each section within the last five years. However, UF Law may take into account your GRE performance as a whole.

#### What if I take both the LSAT and the GRE?

If an applicant has one or more valid LSAT scores within the last 5 years, those LSAT scores will be automatically submitted through the CAS report. If the applicant has also taken the GRE, the applicant must apply with just an LSAT score and should not submit their GRE to UF Law.

### How will UF Law evaluate an application that has both a LSAT and GRE score?

UF Law will only evaluate the LSAT score. If an applicant has a reportable LSAT score, the applicant must apply with only a LSAT score and should not submit their GRE to UF Law.

#### What if I take the LSAT after I was admitted with a GRE score?

Applicants are instructed to apply with either an LSAT <u>or</u> GRE score. Applicants admitted without an LSAT score, who subsequently take the LSAT, will be subject to reconsideration of their admission.

### Will UF Law hold my application if I apply before a future GRE test date?

Unlike the LSAT, the Admissions Committee will not know if a student has a pending GRE score. If an applicant does not have a valid standardized test score, the application will be considered incomplete and will not be ready for review. If an applicant has a standardized test score on file, the application will be considered complete and ready for review. The applicant will need to contact the Admissions Office at <a href="mailto:admissions@law.ufl.edu">admissions@law.ufl.edu</a> if they would like for their application to be held pending the future test score. The Admissions Office will only hold applications through the priority date, March 15, 2022.
