- 9:00 a.m. LCA Chair James Cunningham welcomed members and called the meeting to order. He noted the passing of two great UF Law leaders, Fredric Levin and Judge Stephan Mickle. A motion to accept the Fred Levin Memorial Resolution was seconded and approved by the body without dissent.
- 9:17 a.m. State of the Law School Address Dean Rosenbury presented the State of the Law School address including updates on application trends, OCI, the Bailey Courtroom renovation, faculty staffing and the Al initiative. She thanked board members for their support.
- 9:48 a.m. Special Topic: Al University Provost Joe Glover presented UF's Al initiative which was launched by a \$60M supercomputer gift by NVIDIA founder Chris Malachowsky. The technology will be used for many applications including curriculum and research. UF plans to hire 100 more faculty members in the Al space. All SUS campuses will participate, and other partnerships are expected.
- 10:15 a.m. Office of Admissions Update Assistant Dean Paul Rollins presented updates on entering student credentials, recruiting and diversity goals, and thanked alumni for their support.
- 10:27 a.m. Career & Professional Development Update Assistant Dean Janice Shaw thanked Derek Bruce and the Career Committee for participating in practice interviews. There are 150 employers participating in OCI. She will invite LCA members to upcoming networking events.
- 10:45 a.m. Development & Alumni Affairs Update Sr. Director Michael Farley announced the celebration of the life of Judge Stephan Mickle scheduled for February 13 at the Phillips Performing Arts Center. He thanked the LCA Executive Board for funding Judge Mickle's portrait that now

hangs in the MLAC foyer. UF Law's campaign total is \$57M+ and about 114% of the Go Greater goal. He also presented LCA giving rates, alumni demographics, future programming and fundraising efforts, and 2021 alumni awards.

Shannon Sumerlin thanked alumni mentor volunteers. Her current focus includes the Tax program, gift and estate planning, and Gator Giving Day om February 18, 2021. She asked members to serve as social ambassadors for the event.

Dan Hoffman shared that his current focus is the HBCU scholarship and AI donations. He asked members to contact him about their support for either one or referrals to other alumni.
