Course Materials

The assigned casebook for the course is Ascher & McCouch, Gratuitous Transfers (7th ed.) (West 2019). Students should also have a copy of the Florida Statutory Supplement and handout problems, which will be posted on the course website (TWEN). For additional background reading (optional, not required), students may wish to consult McGovern, Kurtz & English, Principles of Wills, Trusts and Estates (concise hornbook) (2d ed.) (West 2011).

Course Objectives

The primary objective of the course is to introduce students to fundamental concepts and doctrines of inheritance law, including intestate succession, wills, and trusts. The course provides an essential grounding for students who wish to pursue advanced courses in fiduciary administration, future interests, and estate planning, as well as a general survey for students who intend to practice in other areas.

Class Meetings and Attendance

Class will meet at 9:00–10:15 a.m. on Wednesday, Thursday, and Friday, beginning Wednesday, January 20. In-person class sessions will be held in MLAC Room 213; remote sessions will be accessible via Zoom. Students attending in person must wear face coverings at all times during class and must comply with all applicable law school policies and requirements. Students are not permitted to make, post, or circulate audio or video recordings of class sessions. Some class meetings may be held remotely on relatively short notice due to health and safety concerns during the current pandemic. Therefore, all students should arrange to have a reliable internet connection and access to Zoom. Regular and punctual class attendance is required. A student with more than four unexcused class absences may be penalized in the final grade or excluded from the course. Students should be prepared to discuss the assigned readings in class, and may expect to spend up to two hours of preparation for every class hour.

Topics will be covered in the following order, with assigned reading in the casebook, supplemental material (posted on TWEN) and Florida Statutes as indicated. The assigned reading for the first week of class is Chapter 1 of the casebook (pp. 1–54).
