Administrative Focus and Select Accomplishments

I collaborate with the President, Provost, University Board of Trustees, alumni, faculty, staff, and students to raise the national and international profile of UF Law. Among other accomplishments, we have together:

- Increased JD applications by over 200% and student scholarships by 987%
- Enrolled seven of the most accomplished and diverse classes in UF Law's history, including increasing the median LSAT from 157 to 169 and median undergraduate GPA from 3.50 to 3.90 and reducing the acceptance rate from 61.8% to 16.94%
- Raised over \$105 million to support UF Law students, faculty, and initiatives, including:
 - \$2 million to endow a new HBCU Pathway to Law Program that provides full-tuition scholarships to graduates of HBCUs who enroll at UF Law
 - A \$1.8 million gift to support students from China who enroll at UF Law
 - An additional \$25 million in current use funds designated for student scholarships, including merit-based scholarships and guaranteed scholarships for admitted students who are the first in their families to attend college (20% of the 1L class)
 - A \$20 million gift, the largest from a living UF Law alum, to support health law
 - A \$2 million gift to endow UF Law's first Chair in Labor and Employment Law
 - A \$2 million gift to immediately fund programs at UF Law and UF's College of Journalism and Communications designed to strengthen our democracy and the rule of law by identifying and combatting disinformation
 - A new \$40 million estate gift upon the passing of our namesake, Fredric G. Levin
- Recruited ten new tenure-track and seven new tenured professors to the faculty, including two senior tax scholars, as well as twenty-two non-tenure-track professors
- Started a Veterans' Clinic, an Immigration Clinic, and a Low-Income Taxpayer Clinic
- Improved job placement after graduation and implemented a coaching-based approach to career and professional development
- Renovated over 40,000 square feet of law school facilities

As a result, UF Law has achieved its highest ever ranking in *U.S. News and World Report*, rising from #48 to #21 among all law schools and from #24 to #6 among public law schools.

During the summer and fall of 2020, I collaborated with the University and UF Health to develop and execute a pilot program for in-person instruction for over 500 students at UF

Law. The pilot was a success, with no Covid-19 transmission on the law school campus (according to wastewater testing), and the pilot ultimately became a model for much of the University campus during the spring of 2021. I currently collaborate with the deans of the other colleges at the University to implement a multi-disciplinary Artificial Intelligence Initiative, and I am collaborating with the Provost and the deans of our business and engineering colleges as we plan to open a West Palm Beach campus for graduate and professional students. I also served on the Deans and Directors Development Council and on the search committee for the General Counsel of the University, and I currently serve on the University Budget Model Optimization Effort's Strategic Funding Transparency Committee and on the search committee seeking to hire the University's new Vice President for Human Resources. At the request of the President, I served on the seven-person task force he appointed to review the University's practices regarding requests for approval of outside activities involving potential conflicts of interest and conflicts of commitment. I recently concluded my service on the University Presidential Search Committee.

I give speeches about the future of legal education at county bar associations and inns of court throughout the state of Florida. I also speak about diversity, implicit bias, gender and leadership, and sexual harassment at state judicial conferences and trainings; regional meetings of the Florida Association for Women Lawyers; ABA section and midyear meetings; and meetings of public company directors. I served on the Florida Supreme Court Commission on Professionalism and Civility and on The Florida Bar's Special Committee on Gender Bias, and I continue to participate in deans' summits and other initiatives of The Florida Bar's Young Lawyers Division and the Florida Board of Bar Examiners.
